
Notice of Public Hearing

Consider Changes to the Classified Service Classification and Pay Plan

On Tuesday, July 6, 2010 at 9:00 A.M., Conference Room B, Second Floor, William E. Powers Building (Department of Administration), One Capitol Hill, Providence, Rhode Island 02908-5890, the Director of the Department of Administration, Rosemary Booth Gallogly will hold a public hearing in accordance with the provisions of Sections 36-3-3 (17) and 36-4-15 of the General Laws of 1956, as amended, to consider revisions to the Classified Service Classification and Pay Plan. The changes are:

- 3.0% general salary increase effective Sunday, January 2, 2011 (postponed from July 1, 2010 by agreement of the parties) and 3% general salary increase effective Sunday, June 19, 2011 for eligible classified service organized employees as a result of negotiated wage settlements due to collective bargaining between the State of Rhode Island and the:
 - RI Council 94, AFSCME, AFL-CIO
 - Laborers' International Union of North America – RI Laborers' District Council (LIUNA)
 - RI Alliance of Social Service Employees – Local 580, SEIU (RIASSE)
 - Department of Administration - Association of Administration Supervisors
 - Department of Administration – Council of Budget Personnel (Division of Budget)
 - International Federation of Professional and Technical Engineers – Local 400 (IFPTE)
 - National Education Association – Association of Clerical-Technical (ACT/URI - NEARI)
 - National Education Association – Educational Support Professional Association (ESPA/CCRI - NEARI)
 - National Education Association – Professional Staff Association (PSA/DOH - NEARI)
 - RI Employment Security Alliance– Local 401 (RIESA)
 - RI Probation and Parole Association Clerical/Aides Unit and Supervisory/Counselor Units (RIPPA)
 - RI State Employed Physicians Association
 - National Association of Government Employees - Local 79 (NAGE)
 - United Nurses and Allied Professionals, Local 5019 (UNAP)
 - RI Brotherhood of Correctional Officers - Professional Staff (RIBCO)
- 3.0% general salary increase effective Sunday, January 2, 2011 (postponed from July 1, 2010) and 3% general salary increase effective Sunday, June 19, 2011 for eligible classified service non-organized employees.
